If the Company does not receive the enclosed reply form or receive a response indicating the objection from you by 19 March 2021 and until you inform the Company c/o the Hong Kong Branch Share Registrar by reasonable notice in writing according to the relevant laws and regulations, you are deemed to have consented to receive the Website Version of all future Corporate Communications, and a written notification of the publication of the Corporate Communications on the Company's website will be sent to you.

You have the right at any time by reasonable notice in writing or using email at <a href="mailto:xinyienergy.ecom@computershare.com.hk">xinyienergy.ecom@computershare.com.hk</a> to the Company c/o the Hong Kong Branch Share Registrar to change the choice of means of receipt and/or language of all future Corporate Communications.
